What *really* is internal audit?

- IA Code: 'help board and management protect assets, reputation and sustainability of the organisation'
- Build trustee confidence that key risks are being managed
- Better placed to anticipate/respond to shocks
- Help build resilience

An undervalued tool for charities?

- IA is mandatory for public sector
- FS regulators explicitly demand "robust internal audit functions" and had active role in IA Code for FS
- Internal financial controls checklist reference
- *"internal audit, meaningful briefing and reporting by the executive and other assurance mechanisms are critical."* Charity Commission's 2019 Oxfam Inquiry

<u>BUT</u> IA is not yet mandatory or officially recommended by charity regulators or charity governance code!




