



Q2 Which region are you based in?






Q5 Do you own the freehold of any property?



Q6 Do you lease property from the following? (Please select all that apply)





Q7 What type of property do you have? (Please select all that apply)





Q8 Please estimate your charity's income in the past year: (please select)





Q10 Has your charity spent money on property management training/education in last three years?



Q11 If you answered yes to the above, roughly how much did you spend annually? (in £)







Q15 How easy have you found it to access resources and information that you need to deal with your property related issues?








